4. Energy Management Item (Handout #2 & #3)

Debra Fitzsimons reviewed the documents with the committee members.

Davit Khachatryan explained that IVC would receive a rebate from Southern California Edison from a project funded by basic aid money in the approximate amount of \$15,000. Debra Fitzsimons stated that after conferring with the Chancellor, she recommends allowing the colleges to keep the rebates, even for projects that were funded by basic aid. This is to encourage energy savings. However, we should document this into language in the administrative regulation.

Action Item: Add to BP & AR-3110 “how energy projects and rebates are handled”.

5. Board Item for Basic Aid (Handout #4, #5, #6 and #7)

Debra Fitzsimons reviewed the recommendations and presentation for the June 17, 2013 Board of Trustees meeting with the committee members and distributed handout #5 and #6 as revised pages of the Final BAARC Recommendations.
