 - Regional banking still disruptive, risks still exists.
 - Earnings stronger than expected. Will experience more headwinds going forward at end of year. **Recent Developments**

Endowment Fund

• Slightly rebalanced portfolio from International Equities to Fixed Income in order to stay within IPS mandated asset allocation ranges.

Recommendations

General Fund

- Maintain asset allocation targets based upon 2023 Capital Market Assumptions
 - US Equity: 19.0%
 - International Equity: 19.0%
 - Fixed Income: 42.0%
 - Alternatives: 20.0%
- Trim Breckinridge Intermediate Gov/Credit by 5.0% and use proceeds to increase Western Asset Core Plus Fixed Income
 - Continue to extend duration to lock in higher yields as we believe the Fed is at or nearing the end of their aggressive rate hike cycle
- Trim SPDR S&P 1500 Composite Stock Market and Aristotle Value Equity and use proceeds to \rightarrow
 - Establish NEW ~2.5% to WisdomTree US Divided ETF (DTD)

- Fund designed to track the performance of the WisdomTree US Dividend Index, which tracks dividend-paying US companies that pay regular cash dividends
- To be included in the index, a company must pay regular cash dividends, have a market cap
 of at least \$100MM, and have an average daily trading volume of at least \$100,000 three
 months prior to the index screen

Endowment Fund

- Update asset allocation targets based upon 2023 Capital Market Assumptions
 - US Equity: $28.0\% \rightarrow 27.0\%$
 - International Equity: 28.0% →27.0%
 - − Fixed Income: $24\% \rightarrow 26.0\%$
 - Alternatives: 20.0%
- Rebalance portfolio toward updated asset allocation targets
 - Within Fixed Income split proceeds equally between Breckinridge Intermediate Fixed Income and Western Asset Core Plus
- Trim SPDR S&P 1500 Composite Stock Market and Aristotle Value Equity and use proceeds to →

 Establish NEW ~5.0% to WisdomTree US Dividend ETF (DTD)
