 - Asset Class Returns 2023 numbers are very positive with the exception of Managed Futures and Commodities
 - August, September and October were really negative months for both stocks and bonds.
 - November completely reversed course and was the 7th highest monthly return in the last 100 years for the S&P 500.
 - Ended up a really strong year for both stocks and bonds.
 - During an election year, we see elevated volatility this time of year before we know who the candidates will be, dampened volatility in July, Aug, Sept. Oct., normalized volatility right around the election in November and lower volatility in December.

 - 4th quarter strong
 - Asset allocations relatively close to our targets.

- Rebalance portfolio from Liquid Alternative Investments to Core Plus Fixed Income Endowment Fund
- Rebalance portfolio from Us Equity to Core Plus Fixed Income

Recommendations

General Fund

- Trim iShares Core MSCI EAFE and Vanguard FTSE Emerging Markets by ~1.0% each and use proceeds to →
 - Establish NEW ~2.0% position in Martin Currie Emerging Markets SMA
 - Add dedicated active management to Emerging Markets and align exposure with Endowment Fund
 - Martin Currie, based in Edinburgh, Scotland, is one of the longest tenured EM managers in the business. Their approach seeks to identify mispriced business through fundamental research, and invest in high quality companies with strong growth opportunities while employing a disciplined approach to valuation.
 - Provides a hybrid structure that uses U.S-listed American Depository Receipts (ADR's) in conjunction with a no-fee pooled vehicle to provide exposure to foreign ordinary shares of emerging market companies that are otherwise difficult to access.
